**1. Regulation of the European Parliament and of the Council on the transfer to the General Court of jurisdiction at first instance in disputes between the European Union and its servants [First reading] (LA)**

The Council approved the European Parliament's position at first reading and the proposed act has been adopted, with the UK delegation abstaining, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. (Legal basis: Articles 257 (1st and 2nd subparagraphs) and 281 (2nd paragraph) TFEU and Article 106(a)(1) EURATOM).

**2. Decision of the European Parliament and of the Council providing further macro-financial assistance to Tunisia [First reading] (LA+S)**

PE-CONS 9/16 ECOFIN 204 UEM 87 CODEC 247

The Council approved the European Parliament's position at first reading and the proposed act has been adopted, pursuant to Article 294(4) of the Treaty on the Functioning of the European Union. (Legal basis: Article 212 TFEU).

### **Statement by the European Parliament and the Council**

"This Decision is adopted without prejudice to the Joint Declaration adopted together with Decision 778/2013/EU of the European Parliament and of the Council providing further macro-financial assistance to Georgia, which is to continue to be regarded as the basis for all decisions of the European Parliament and Council providing macro-financial assistance to third countries and territories."
