The Committee discussed and agreed the revised compromise package, including Annex II, proposed by the Presidency and gave the mandate for agreement with the European Parliament. Questions were raised on the Presidency's approach regarding Annex II. The Hungarian delegation requested a change in pollutants in Annex II: increase by 4% for SO₂ and reduction by 6% for PM_{2.5}. The Romanian delegation indicated increased percentages that would have been voluntarily accepted for Annex II: 1% for SO₂, 2% for PM_{2.5}, 2% for NH₃, 2% for NO_x and 2% for VOC and asked for their formal request for written explanations on the methodology used to be mentioned in the meeting's summary record. The Polish delegation requested the application of the "weighted voting rules [applicable upon request]". One delegation had a scrutiny reservation. Two delegations announced their intention to abstain and five delegations announced their intention to vote against at the moment of formal adoption. In reply to several delegations the Commission confirmed that Article 4 paragraph 2 (new) on the reduction trajectory was an obligation of effort and did not imply an obligation on results.

Statements by the Commission

"DECLARATION BY THE COMMISSION ON THE REVIEW OF METHANE EMISSIONS

The Commission considers that there is a strong air quality case for keeping the developments of methane emissions in the Member States under review in order to reduce ozone concentrations in the EU and to promote methane reductions internationally.

The Commission confirms that on the basis of the reported national emissions, it intends to further assess the impact of methane emissions on achieving the objectives set out in Art. 1(1a) of the NEC Directive and will consider measures for reducing those emissions, and where appropriate, submit a legislative proposal to that purpose. In its assessment, the Commission will take into account a number of ongoing studies in this field, due to be finalised in 2017, as well as further international developments in this area.

DECLARATION BY THE COMMISSION ON THE PROCEDURE OF ADOPTION OF IMPLEMENTING ACTS

The Commission underlines that it is contrary to the letter and to the spirit of regulation 182/2011 (OJ L 55 of 28.2.2011, p. 13) to invoke Article 5§4, subparagraph 2, point b) in a systematic manner. Recourse to this provision must respond to a specific need to depart from the rule of principle which is that the Commission *may* adopt a draft implementing act when no opinion is delivered. Given that it is an exception to the general rule established in Article 5§4 resource to subparagraph 2, point b), cannot be simply seen as a "discretionary power" of the Legislator, but must be interpreted in a restrictive manner and thus must be justified."

The Committee confirmed the conclusions of the Mixed Committee and approved the final compromise text. The Presidency will send a letter confirming the agreement to the chair of the EP's LIBE Committee.

Statement by the Commission

"The Commission welcomes that the co-legislators maintained the appointment of the Executive Director by the Management Board on the basis of a shortlist drawn up by the Commission following an open and transparent selection procedure, as foreseen in the Common Approach on EU Decentralised Agencies. However, the Commission regrets that the agreement reached by the co-legislators deviates from the Common Approach as regards the appointment process. The Commission sees no objective reasons for this deviation, which could affect the autonomy of the agency. The modalities of appointment of the EBCG's Executive Director should therefore not be considered as a precedent for other agencies' founding acts."

Statement by the Council Legal Service

"Regarding Recital 39a, the Council Legal Service confirmed that the references to Title II of Regulation (EU) No 2016/399 as well as to the Protocol 19 on the Schengen acquis integrated into the framework of the European Union apply to Croatia".

Statement by Romania

"Concerning recital (39a), Romania emphasizes that any interpretation of the concept of “*external borders*” should cover the borders of the Member States listed in Article 52 TEU and in Article 1 of Protocol 19 on the Schengen acquis integrated into the framework of the European Union, with third countries.

The same applies for the definition included in article 2 para.1 of the proposal, in reference to article 2 point 2 of Regulation no. 399/2016 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code)."

Joint Statement by Cyprus, Greece, Italy, Malta and Spain

"With regard to Article 14(1) of the Proposal for a Regulation of the European Parliament and of the Council on the European Border and Coast Guard and repealing Regulation (EC) No 2007/2004, Regulation (EC) No 863/2007 and Council Decision 2005/267/EC, Cyprus, Greece, Italy, Malta and Spain thank the Presidency for the formulation in document ST10743/16 and for the efforts deployed to make the afore mentioned paragraph in line with the basic principle of article 13, which states (paragraph 1) that “a Member State may request the Agency for assistance in implementing its obligations with regard to the control of the external borders...” and in paragraphs 2-3a lists possible measures that the Agency can take to assist the requesting Member State.

In the light of the next procedural steps for the finalization of the political agreement with the European Parliament, Cyprus, Greece, Italy, Malta and Spain deem that the current alignment of article 14(1) with article 13 remains key for the coherence and clarity of the text."

Statement by the Council Legal Service

"The Legal Service confirms that pursuant to Article 2(1)(a) on its scope, the Legal Aid Directive applies to suspects and accused persons in criminal proceedings who are deprived of liberty. The purpose and effect of the new recital (15b) is to clarify that the situations listed therein do not constitute a deprivation of liberty within the meaning of Article 2(1)(a) of the Directive and are, as a consequence, out of the scope of the Directive."

Statement by the United Kingdom

"The United Kingdom regrets that it is unable to vote in favour of the revised Rules of Procedure for both the EU General Court, and the European Court of Justice. While we support some of the proposals, we have concerns relating to the amendments to Article 105, and the complementary revisions proposed for the Court of Justice. In addition we have yet to complete our domestic Parliamentary scrutiny procedures on these proposals.

The United Kingdom does not disagree that where a case moves to the Court of Justice, a similar mechanism involving confidential material will be required where the confidential material considered by the General Court is relevant to the issue(s) raised on appeal. However, in the absence of established systems for securing sensitive material, we are concerned that the Rules as drafted could create unnecessary security risks. This relates in particular to the proposal for automatic retention of classified material by the General Court and transmission of such material to the Court of Justice, regardless of the circumstances.

The United Kingdom notes that individual Member States would be free to choose whether or not to use the new mechanism, and that the regrettable absence of sufficient safeguards for sensitive information in the proposed Article 105 will limit the use that the United Kingdom will make of this mechanism.

The United Kingdom suggests that the Council and Court review both mechanisms in light of practical experience."
