Note 1: €108,050,000 for EUPOL Afghanistan was approved by RELEX Counsellors Working Group in 2013. €77.8 mln was financed through 2013 budget and €30.25 mln will be financed through 2014 budget.

Note 2: BIS amounting €1,040,000 for Support of WHO activities (WHO – II), and €3,600,000 for NPD consortium think tanks (Think Tank II) were already approved by RELEX Counsellors Working Group in 2013. The Commission has requested a carry over of the funds remaining in their respective budget lines. Should this request be approved, those two actions will be partially funded from 2013 budget, otherwise, they will be financed from the budget 2014.

Note 3: Council Decision 2013/668/CFSP was adopted by the Council in 2013. The Commission has requested a carry over of €1,727,000 from 2013 budget to 2014 budget.
