- 1. The <u>General Secretariat of the Council</u> has been informed by the Luxembourg Government of its decision to nominate Mr Gil BELLING as its member in the category of Government representatives on the CEDEFOP Governing Board, replacing Mr Antonio DE CAROLIS.
- Under Article 4 of Regulation (EEC) No 337/75, as amended by Regulation (EC) No 2051/2004, the members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.

### THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof <sup>1</sup>,

Having regard to the nomination submitted by the Luxembourg government,

Whereas:

- (1) By its Decisions of 14 July 2015<sup>2</sup> and of 14 September 2015<sup>3</sup>, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2015 to 17 September 2018.
- (2) A member's seat is available for Luxembourg on the Governing Board of the Centre in the category of Government representatives as a result of the resignation of Mr Antonio DE CAROLIS.
- (3) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2018.
