Subject:	COMMISSION DELEGATED REGULATION (EU) .../... of 28.7.2016 supplementing Regulation (EU) No 600/2014 of the European Parliament and of the Council with regard to regulatory technical standards for the reporting of transactions to competent authorities - Decision to extend the period for raising objections

1. The Commission notified on 22 August 2016 the above delegated act¹ to the Council in accordance with the procedure set out in Article 290 TFEU and with Article 11 (2) of Regulation (EU) No 1095/2010². The Council has one month, i.e. until 22 September 2016 to object to it.

2. Following the silence procedure within the framework of the Working Party on Financial Services, which expired on 1 September 2016, all delegations agree that the objection period should be extended by one month in accordance with Article 13(1) of Regulation (EU) No 1095/2010, i.e. until 22 October 2016.
3. It is therefore suggested that the Permanent Representatives Committee invites the Council to decide to extend the period for raising objections by one month. The Commission and the European Parliament should be informed accordingly.
