THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union¹, and in particular Articles 23 and 24 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

Whereas:

- (1) By its Decisions of 25 September 2014¹ and 7 November 2014², the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers (the 'Committee') for the period from 25 September 2014 to 24 September 2016.
- (2) The members remain in office until they are replaced or their appointments are renewed .
- (3) Members and alternate members of the Committee should be appointed for a period of two years,
