Dear Chair,

On behalf of the Committee on Agriculture and Rural Development (AGRI) of the European Parliament, I would like to formally invite the Council to grant access for the Members of this Committee to the mandate for the negotiation of a deep and comprehensive free trade agreement with Tunisia which it is about to adopt after the summer recess. I also express my full support for the similar demand already introduced by the Committee on International Trade (INTA).

The AGRI Committee has debated on the state of trade relations with Tunisia on various occasions, most recently when it adopted its opinion to the INTA report on the introduction of emergency autonomous trade measures for the Republic of Tunisia (Draftsperson: Clara Eugenia Aguilera García). As these trade negotiations with Tunisia will include in large parts agricultural matters, many of them considered to be very sensitive for a number of agricultural sectors in the European Union in general, and in its Southern Member States in particular, the AGRI Committee considers it is its right to be fully informed about the content of this mandate before negotiations actually start. More generally, we are of the view that all trade negotiating mandates involving a significant agricultural component should be made immediately available to the Members of the AGRI Committee as a matter of principle.

Finally yet importantly, I would like to take this opportunity to wish you a lot of success during the Slovak presidency.
