Subject:	Satisfaction survey results

- 1. In March 2016, the GSC launched a survey to assess the level of satisfaction among delegates of the Council Security Committee with the services provided.
- 2. The GSC would like to thank the delegations who took the time to respond to the survey. Reactions were received from seventeen Member States and additional comments were provided by eight of them.
- 3. Delegations will find attached a summary of results, including a summary of comments under each section of questions. The results show a generally high degree of satisfaction with the services delegations receive from the GSC. In order to improve services to delegations in some of the areas of weakness signaled, the Chair intends to take the following steps:
 - (i) the Chair will prepare at the start of each year a schedule of meetings, with the possibility of organising some meetings over one and a half days;
 - (ii) a renewed effort will be made to ensure papers for discussion are circulated at least ten working days ahead of any meeting (in line with the Committee's agreed working methods);

- (iii) with regard to use of the Delegates' Portal, the Secretariat will take contact bilaterally with delegations experiencing difficulties.
- Delegations are invited to suggest at the Committee's next meeting any additional 4. improvements to the GSC's working methods in the light of the survey's findings.

(A) Comments/suggestions:

Meetings of 1,5 - 2 days duration would enable more fruitful and thorough discussions, but also bilateral debates which could ease resolution of difficult matters, especially when the agendas are heavy. On certain topics such a longer meeting followed by decision making meeting could be a useful practise.

The importance of breaks (coffee, lunch breaks) was highlighted as an useful opportunity for meeting other delegates and discussing bilateral issues. This aspect and the fact that some topics require longer discussion should be taken into consideration when planning the agenda.

It was also proposed to schedule meetings one year ahead that would allow for easier planning for delegations. There is a clear support for planning meetings in coordination with other Committees (EEAS, Commission).

Delegations requested documents to be sent more time in advance (at least two weeks before the meeting) which would allow to consult nationally and prepare an MS opinion. Also, steering notes

12353/16 MO DGA SSCIS could already at the time of release clearly point out problematic areas of the agenda items which are to be addressed at the meeting.

Some Member States highlighted that the CSC needs better coordination with other preparatory bodies of the Council. The Chair and CSC should be vigilant within the Council and should function better as an early warning system for the NSAs, so that the CSC is involved when EUCI issues are debated.

(B) Comments/suggestions:

Member States valued the participation of the Agencies' representatives what is reflected in the outcome of the survey. However, it was pointed out that the input and participation of agencies' delegates in respective matters should be encouraged to be more pro-active and substantive.

The fact that the Chair permits adequate time for delegations to intervene was appreciated. Also conducting the meeting in a commendable way, proposing draft solutions and producing clear conclusions was appreciated.

(C) Comments/suggestions:

One Member State proposed that it would be useful to have a list of participants and their contact details attached to the outcome of proceedings. Receiving an annual summary of discussions and actions taken by the CSC would also be valuable.

The outcome of proceedings was considered as useful but some delegations expressed the need to summarise and elaborate discussions in greater detail in the outcome as well as to have it circulated in shorter period of time after the meeting.
