Subject:	Draft amending budget No 3 to the general budget for 2016: Security of the Institutions

On 30 June 2016, the <u>Commission</u> submitted to the Council draft amending budget (DAB)
 No 3 to the general budget for 2016 concerning additional commitment and payment appropriations necessary to cover increased security expenditure in almost all Institutions, and European Schools. The amount requested is EUR 15.8 million.

This DAB also includes a modification to the establishment plan of the European Parliament with 35 additional posts (1 at AD 5 level and 34 at AST/SC 1 level) for the recruitment of security agents.

This DAB results in an increase of non-differentiated expenditure in the 2016 budget under heading 5 (*Administration*). The necessary payment appropriations will be redeployed from the ITER operational line (item 32 05 01 02) under sub-heading 1a.

The modification to the European Parliament's establishment plan amounts to EUR 0.2 million and is included in the overal amount mentioned above.

 - adopt the Council's position on DAB No 3/2016 as set out in point 2;
 - instruct the Presidency to prepare the budgetary documents to be sent to the
 European Parliament and to approve the draft letter in Annex 2 to that effect;
 - have the Council's position published in the Official Journal of the European Union as set out in Annex 1.
