THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>1</sup>, and in particular Articles 23 and 24 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

Whereas:

- (1) By its Decision of 21 September 2016<sup>2</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers ("Committee") for the period from 25 September 2016 to 24 September 2018.
- (2) The government of Greece has submitted further nominations for several posts to be filled.
