THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work<sup>1</sup>, and in particular Article 8 thereof,

Having regard to the lists of nominations for appointment submitted to the Council by the Governments of the Member States and by the employees' and the employers' organisations,

- (2) The members remain in office until they are replaced or their appointments are renewed.
- (3) The members and alternate members of the Governing Board of the European Agency for Safety and Health at Work should be appointed for a period of three years,
