Full Powers for the signing ceremony of the Agreement establishing the EU-

LAC International Foundation

With reference to communication CM 3531/16 of 12 July 2016, Member States are informed that the abovementioned Agreement has been adopted by the Council today, on 10 October 2016. The signature of the above-mentioned Agreement is envisaged to take place in Santo Domingo on 25-26 October 2016, in the margins of the Meeting of EU-CELAC Ministers of Foreign Affairs

Member States are requested, if required*, to ensure that an instrument of Full Powers, or at least a copy thereof, authorising their plenipotentiary to sign this Agreement, is duly issued and deposited with the Council's Treaties & Agreements Office¹ at any time prior to the signing ceremony.

* Full Powers are required to be issued to any plenipotentiary who is not a Head of State, Head of Government or a Minister for Foreign Affairs (see Article 7 of the Vienna Convention on the Law of Treaties). However, those Member States' Permanent Representatives who have communicated to the General Secretariat of the Council a general authorisation from their authorities to sign EU Agreements on behalf of their country are exempt from this requirement.

Preparation for the signing of the Agreement establishing the EU-LAC International Foundation, scheduled to take place at Punta Cana on 25-26 October 2016, in the margins of the Meeting of EU-CELAC Ministers of Foreign Affairs.

The Agreement will be opened for signature in Punta Cana on 25-26 October 2016 and thereafter in Brussels, at the General Secretariat of the Council of the European Union.

Signatories will be:

the authorised plenipotentiary of each of the 28 Member States

the High Representative of the Union for Foreign Affairs and Security Policy on behalf of the European Union

the authorised plenipotentiary of each of the 33 CELAC States

Full Powers

Before the signature takes place, Member States/CELAC States should prepare the instrument of Full Powers for their respective plenipotentiary (a Communication to Member States will be sent shortly to this effect).

The form in which this instrument is drawn up and the decision as to which authority should delegate these Powers, i.e. Head of State, Head of Government or Foreign Minister, is entirely a matter for each individual Member State/CELAC State based upon its constitutional practice. Heads of State, Heads of Government or Foreign Ministers do not need to produce Full Powers.

The instruments of Full Powers can be deposited with the Council's Agreements Office at any time prior to the signing ceremony.

If, for any reason, a Member State/CELAC State has a problem in producing the original of their Full Powers before 25-26 October 2016, a copy should be forwarded before that date by Email: coordination.accords@consilium.europa.eu, and the original sent as soon as possible thereafter, or alternatively delivered to Thuc-Diem LETAT in Punta Cana on the day of the ceremony.

Article 8 of the Vienna Convention on the Law of Treaties allows for subsequent confirmation of an Act, such as the signing of an Agreement, done without authorisation. Although it is preferable not to have to apply this Article, it does, however, allow for some margin of flexibility in this area. In the event that a Member State/CELAC State does apply this Article, the name and title of the person signing for that Member State/CELAC State must be communicated, in writing, before 25-26 October 2016 to the Council's Agreements Office.

The Secretary-General of the Council of the European Union is the depositary of the Agreement, and the Council's Agreements Office will therefore prepare and print the copy of the book for signature in all languages, with multilingual cover pages, date page and signature pages, on red boarder paper bound in a blue leather cover.

Thuc-Diem LETAT will bring this book to Punta Cana where she will prepare the signature ceremony in cooperation with the EU-Delegation and the Protocol Service of the Dominican Republic.
