Subject: Draft amending budget No 4 to the general budget for 2016: Update of appropriations to reflect the latest developments on migration and security issues, reduction of payment and commitment appropriations as a result of the Global Transfer, extension of EFSI, modification of the staff establishment plan of Frontex and update of revenue appropriations (Own resources)

– *Information to national Parliaments*

1. On 30 September 2016, the Commission submitted to the Council draft amending budget (DAB) No 4 to the general budget for 2016.
2. In order to allow the Council to adopt a position on DAB No 4/2016¹ without delay, the Council has to decide, considering the urgency of the matter, to shorten, in accordance with Article 3(3) of its Rules of Procedure, the eight-week period laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union.

¹ The Council position on DAB No 4/2016 shall contain a recital stating that "*so as to be able to cover urgent funding needs related to migration and security, draft amending budget No 4 to the general budget for 2016 needs to be adopted without delay. Therefore, it is justified to shorten, in accordance with Article 3(3) of the Council's Rules of Procedure, the eight-week period for the information of national Parliaments laid down in Article 4 of Protocol No 1.*"

3. National Parliaments have to be informed thereof.
 4. Accordingly, the Permanent Representatives Committee is requested to suggest that the Council:
 - decide, on the basis of Article 3(3) of its Rules of Procedure, to shorten the eight-week period for the information of national Parliaments laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union;
 - approve the attached communication to be addressed to national Parliaments by the General Secretariat of the Council.

To: National Parliaments

I would like to draw your attention to the fact that, due to the urgency of the matter, draft amending budget No 4/2016 submitted by the Commission on 30 September 2016 needs to be adopted without delay.

In this perspective, the Council wishes to inform national Parliaments that, in accordance with Article 3(3) of its Rules of Procedure, it has to shorten the eight-week period laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union, in order to be able to adopt a position on draft amending budget No 4/2016 in a timely manner.

The Council trusts that the urgency of the matter will be widely understood and shared by national Parliaments.
