Subject: Notification of the appointment of the Deputy National Member and an Assistant to the National Member of Eurojust

Dear Director General,

In accordance with the provisions of Articles 9a(3) and 41 of Council Decision 2002/187/JHA of 28 February 2002 setting up Eurojust with a view to reinforcing the fight against serious crime, as amended by Council Decision 2009/426/JHA, I write to notify you that, under the decision of the Minister for Justice of 28 July 2015 (Ref No MSP-16/2014-OJ-SZ/10), Ms Anna Richterová has been removed from her post as Deputy National Member of Eurojust for the Czech Republic and appointed Assistant to the National Member for the period from 1 February 2016 to 31 January 2020. Subsequently, on the basis of the decision of the Minister for Justice of 17 August 2015 (Ref No MSP-145/2015-OJ-SZ/3), Ms Martina Hlušítková was temporarily appointed Deputy National Member of Eurojust for the Czech Republic, also for the period from 1 February 2016 to 31 January 2020.


Notification by the Czech Republic – Appointment of the Deputy and of the Assistant to the Czech National Member of Eurojust
