The Mission of the Principality of Liechtenstein to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honour to refer to the Council's notification of 7 April 2016 and its own notification of 3 May 2016, the latter informing the General Secretariat of the Council of the European Union of the acceptance of the below mentioned legal act, subject to the fulfilment of constitutional requirements in Liechtenstein in accordance with the second and third sentence of Article 5(2)(a) in combination with Article 5(2)(b) of the Schengen Protocol.

In accordance with Article 5(2)(b) of the Schengen Protocol, the Mission of the Principality of Liechtenstein to the European Union has the honour to notify the General Secretariat of the Council of the European Union that the constitutional requirements regarding the following act have been fulfilled, thereby making the act binding on Liechtenstein:

Regulation (EU) 2016/399 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code) (codification) (OJ L 77/1, 23.03.2016)

The exchange of notes referred to above shall therefore enter into force on the date of this notification.

The Mission of the Principality of Liechtenstein to the European Union avails itself of this opportunity to renew to the General Secretariat of the Council of the European Union the assurances of its highest considerations.
