With reference to the procedure agreed by exchange of letters on 3 and 9 November 1966, you are hereby informed that the Government of the Republic of Peru intends to appoint H.E. Mr Gonzalo GUTIERREZ REINEL Head of Mission of the Republic of Peru to the European Union to replace H.E. Mrs Cristina Ronquillo Rebora.

Your tacit agreement will be assumed on 25 November 2016 unless you make specific objections by that date.

The Ministry of Foreign Affairs, Directorate-General for Protocol and State Ceremony, presents its compliments to the Honourable Delegation of the European Union and has the honour of asking it to agree that Ambassador Gonzalo Gutiérrez Reinel act as Ambassador Extraordinary and Plenipotentiary of Peru to the European Union.

CURRICULUM VITAE

Ambassador Gonzalo Gutiérrez is a career diplomat in the Peruvian Foreign Service. He has a degree in International Relations from the Diplomatic Academy of Peru. He received a Master's degree in International Public Policy from the School of Advanced International Studies, Johns Hopkins University, Washington D.C. He has also pursued graduated studies at the London School of Economics and Political Science in the United Kingdom and the JFK School of Government of Harvard University.

He has the rank of Ambassador in the Peruvian Diplomatic Service and currently is Advisor to the Minister of Foreign Affairs. Between 2014 and 2015 he was Peru's Minister of Foreign Affairs. Previously he was the Ambassador of Peru to the People's Republic of China, and non-resident ambassador to Mongolia, North Korea and Pakistan. He has been Ambassador, Permanent Representative of Peru to the United Nations, and Vice-President of the Economic and Social

Council (ECOSOC) of the United Nations. From 2006 to 2009 he was Vice Minister of Foreign Affairs. At the Ministry of Foreign Affairs of Peru he has been Under-Secretary for Economic Affairs, Executive Director of the Bureau for Trade Promotion, Acting Undersecretary for the Americas, and Director for South America.

As a Foreign Service Officer, he has served at the Peruvian Mission to the United Nations in New York, and the Peruvian Embassies to the United States and Chile. He has also been Deputy Permanent Representative of Peru to the European Office of the United Nations and the International Organizations headquartered in Geneva, Switzerland.

Ambassador Gonzalo Gutiérrez was a professor at the Peruvian Diplomatic Academy teaching the course "International Economic Organizations". He has also been professor of Foreign Policy at the Peruvian University of Applied Sciences (UPC) and the University San Martin de Porres.

He is the author of:

- "Settlement of Disputes in the World Trade Organization: Peru in the case against France and the European Community for the commercial designation of Scallops" (1996);
- "The institutional evolution of the Andean Integration Process" (1996);
- "The pre-history of the WTO: The creation of GATT and Peru's accession" (1999);
- "Pisco: Arguments for the International Protection of the Peruvian Appellation of Origin", (2003).

Ambassador Gonzalo Gutierrez has been awarded by the PeruviarUSovernmenTwith the ürand Trosses oFthe OrdeFoHhe Sun, theOrder of Merit for Distinguished Services and the Diplomatic Service Order. The Chilean and Paraguayan Governments have granted him the Grand Crosses of the Order of Merit; the Argentinean Government granted him the Grand Cross of the "Orden del Libertador San Martin". He has also received the Grand Cross of the Order of the Civil Merit from the Spanish Government; and from the Government of Thailand the Knight Grand Cross of the Crown of Thailand.

He is Member of the Society of Founders of Independence of Peru.
