Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>1</sup>, and in particular Articles 23 and 24 thereof.

Whereas:

- (1) In its Decision of 20 September 2016<sup>2</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2018.
- (2) A seat as member in the government representatives category has fallen vacant as a result of the resignation of Ms Paloma MARTÍNEZ GAMO.
- (3) The Government of Spain has submitted a nomination for the vacant seat,
