EXPLANATORY MEMORANDUM

1. CONTEXT OF THE DELEGATED ACT

Regulation (EU) No 652/2014 of the European Parliament and of the Council of 15 May 2014, provides for, *inter-alia*, the management of expenditure relating to the food chain and animal health. The animal diseases and zoonoses which qualify for funding under the eradication, control and surveillance programmes are listed in Annex II to this Regulation.

In order to take account of the situations that are provoked by those animal diseases and zoonoses that have a significant impact on livestock production or trade, the development of zoonoses which pose a threat to humans, or new scientific or epidemiological developments, Article 10(2) of this Regulation empowers the Commission to adopt delegated acts, in respect of supplementing the list of diseases and zoonoses of Annex II.

The epidemiological situation of sheep and goat plague, sheep pox, goat pox and lumpy skin disease that are listed only under Annex I to Regulation (EU) No 652/2014 that includes diseases for which only emergency measures can be taken, has been evolving in the last year and the EU is under threat of those diseases.

Sheep and goat plague and sheep pox or goat pox are very contagious viral diseases of sheep and goats, endemic, respectively, in East Africa, Arabian Peninsula, Middle Eastern countries and India, and North African countries, Middle Eastern and Asian countries. Sheep and goat plague is widespread in Africa and Asia and it has been reported in Turkey and Northern Africa countries since 2014. Sheep pox and goat pox are endemic in North African countries, Middle Eastern and Asian countries, with recurrent epidemics in Greece and Bulgaria, as in 2013–2014, entering from bordering third country (Turkey).

Those diseases have a severe impact on the profitability of ovine and caprine farming causing disturbance to trade within the Union and export to third countries.

As a consequence, in order to implement an appropriate annual-multiannual surveillance programmes for early detection, rapid reaction and eradication of the above-mentioned diseases, it is necessary to supplement the list of animal diseases and zoonoses of Annex II to Regulation (EU) No 652/2014 to include them.

2. CONSULTATIONS PRIOR TO THE ADOPTION OF THE ACT

The act has beensubject to the following procedures: intra-SANTE consultation, written consultation of experts of the Member States that agreed on the proposal, without comments, inter-service consultation with the concerned DGs and SG, adoption by the Commission, notification simultaneously to the European Parliament and to the Council: with 2 months period for expressing objections, that may be extended to other 2 months upon request of one of the two legislators. If no objections, the delegated act will enter into force the day after the publication in the Official Journal of the European Union.

3. LEGAL ELEMENTS OF THE DELEGATED ACT

Article 10(2) of Regulation (EU) No 652/2014 empowers the Commission to adopt delegated acts, in accordance with article 40 of the same Regulation, in order to supplement the list of animal diseases and zoonoses of Annex II to the above Regulation.

Article 40 of Regulation (EU) No 652/2014 lays down the conditions under which the power to adopt delegated acts is conferred to the Commission.

The Commission can supplement the list of animal diseases and zoonoses of Annex II to Regulation (EU) No 652/2014 only by adopting a delegated act amending that Annex.

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 652/2014 of the European Parliament and of the Council of 15 May 2014 laying down provisions for the management of expenditure relating to the food chain, animal health and animal welfare, and relating to plant health and plant reproductive material, amending Council Directives 98/56/EC, 2000/29/EC and 2008/90/EC, Regulations (EC) No 178/2002, (EC) No 882/2004 and (EC) No 396/2005 of the European Parliament and of the Council, Directive 2009/128/EC of the European Parliament and of the Council and Regulation (EC) No 1107/2009 of the European Parliament and of the Council and repealing Council Decisions 66/399/EEC, 76/894/EEC and 2009/470/EC¹ and in particular Article 10(2) thereof,

Whereas:

- (1) The specific conditions to be taken into account as referred to in Article 10(2)(a) and (c) of Regulation (EU) No 652/2014 are met for sheep and goat plague, listed by the World Organisation for Animal Health (OIE) as 'peste des petits ruminants', sheep pox, goat pox and lumpy skin disease that are listed only in Annex I to that Regulation, which includes diseases that qualify for funding under Article 6 of that Regulation concerning emergency measures.
- (2) Sheep and goat plague is a highly contagious viral disease of sheep and goats, endemic in East Africa, the Arabian Peninsula, the Middle Eastern countries and India. It is widespread in Africa and Asia and it has been reported in Turkey and Northern Africa countries since 2014.
- (3) Sheep and goat plague is transmitted via direct contact, and the disease would mainly be transferred to infection-free areas by transport of infected animals. While goats are considered to be more susceptible than sheep, the infection in the latter may go unnoticed.

- (4) Sheep pox and goat pox are serious and highly contagious diseases of sheep and goat caused by capripoxviruses with a severe impact on the profitability of sheep and goat farming, causing disturbance to trade within the Union and export to third countries.
- (5) Sheep pox and goat pox are endemic in North African countries, Middle Eastern and Asian countries, with recurrent incursions into Greece and Bulgaria from a neighbouring third country.
- (6) Lumpy skin disease is a highly infectious viral disease of cattle that can be transmitted by insect vectors and which can have a severe impact on the profitability of cattle farming causing disturbance to trade within the Union and export to third countries. It is endemic in most African countries and in the years 2012 and 2013 it has spread to the Middle East and Turkey. Several outbreaks have occurred in Greece since August 2015 and the disease spread in Bulgaria in March 2016, and subsequently to a number of Western Balkan countries.
- (7) The epidemiological situation of sheep pox, goat pox and lumpy skin disease is evolving rapidly spreading also in the Union territory with significant negative impact on livestock production and trade.
- (8) In addition, as requested by the Commission, the European Food Safety Authority (EFSA) delivered scientific opinions in relation to surveillance measures to be implemented by the Union for the early detection of sheep and goat plague², sheep pox, goat pox³ and lumpy skin disease⁴ to react accordingly to avoid spread of the diseases and eradicate them in a short time.
- (9) Therefore, in order to implement appropriate annual or multiannual surveillance programmes for the early detection of the above-mentioned diseases, it is necessary to add sheep and goat plague, sheep pox, goat pox and lumpy skin disease in the list of animal diseases and zoonoses in Annex II to Regulation (EU) No 652/2014. Article 10(2) of Regulation (EU) No 652/2014 empowers the Commission to adopt delegated acts in order to supplement the list of animal diseases and zoonoses set out in Annex II to that Regulation. The Commission can supplement the list set out in Annex II to Regulation (EU) No 652/2014 only by amending that Annex.
- (10) Annex II to Regulation (EU) No 652/2014 should therefore be amended accordingly,

HAS ADOPTED THIS REGULATION:

Article 1

In Annex II to Regulation (EU) No 652/2014, the following animal diseases are added: 'sheep and goat plague, sheep pox, goat pox and lumpy skin disease'.

Article 2

This Regulation shall enter into force the day after publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
