Subject:	Proposal for transfer of appropriations No DEC 32/2016 within Section III - Commission - of the general budget for 2016

1. On 9 November 2016, the Commission submitted to the Council proposal for transfer of appropriations No DEC 32/2016.

The purpose of this proposal is to transfer from Items 02 01 04 01 (Support expenditure for Competitiveness of enterprises and small and medium-sized enterprises (COSME)) and 02 01 06 01 (Executive Agency for Small and Medium-sized Enterprises - Contribution from Competitiveness of enterprises and small and medium-sized enterprises (COSME)), and from Articles 02 03 03 (European Chemicals Agency - Chemicals legislation) and 26 02 01 (Procedures for awarding and advertising public supply, works and service contracts) a total amount of EUR 2 388 545 in payment appropriations to Article 02 02 01 (Promoting entrepreneurship and improving the competitiveness and access to markets of Union enterprises), and a total amount of EUR 18 508 200 in commitment appropriations to Article 02 02 02 (Improving access to finance for small and middle-sized enterprises (SMEs) in the form of equity and debt), as recorded in document 14126/16 FIN 773.

- 2. The aim of this transfer is to reinforce the Executive Agency for Small and Medium-sized Enterprises' payment appropriations relating to the COSME actions and to respond to the increased market demands for support from financial instruments under the COSME programme.
- 3. <u>The Budget Committee</u> examined this proposal for a transfer at its meeting on 11 November 2016.
- 4. Following that examination, the Budget Committee agreed, by qualified majority, to suggest that the Permanent Representatives Committee advise the Council to approve:
 - the proposed transfer of appropriations;
 - the draft letter in the ANNEX to that effect.
