Subject:	Implementation of the Framework Decision of the Council of the European Union of 22 July 2003 (2003/577/JHA) on the execution in the European Union of orders freezing property or evidence - Information provided to the General Secretariat

Delegations will find attached a table with information about the state of play concerning the implementation of Council Framework Decision 2003/577/JHA of 22 July 2003 on the execution in the European Union of orders freezing property or evidence (OJ L 196, 2.8.2003, p.45). This information is based on information provided by Member States to the Council General Secretariat, to which reference is made in the last column.

In accordance with Article 14, the Framework Decision should have been implemented by 2 August 2005. According to the information received, up to now 25 Member States (BE, BG, CZ, DK, DE, EE, ES, FR, HR, IE, CY, LV, LT, HU, MT, NL, AT, PL, PT, RO, SI, SK, FI, SE, UK) have implemented the Framework Decision in their national legal order.

The information in the table is a summary of the information received: delegations are invited to consult the documents referred to in the last column, in order to obtain more detailed information.
