The Council adopted its position on the draft amending budget No 4/2016 as set out in 13331/1/16 REV 1, by a qualified majority with the UK delegation abstaining, and added the following statements.

Statement by the Council on DAB No 4/2016

"With agreeing to draft amending budget No 4/2016 and the frontloading of the EUR 73.9 million for the provisioning of the EFSI Guarantee Fund, the Council does not pre-empt any decision on Commission proposal COM(2016) 597 final on the extension of the duration of EFSI until 2020. The Council considers this amount to be part-financing of the already agreed EFSI package in 2015."

Statement by the Council on fines

"Due to the specific circumstances characterising amending budget No 4/2016, the Council takes note that the fines which have already become definitive are not entered into the budget as budgetary revenue. The Council recalls the importance of fines being entered into the budget as budgetary revenue as soon as possible and at the latest in the year following the exhaustion of all legal remedies, in accordance with Article 83 of the Financial Regulation and its rules of application.

The Council invites the Commission to inform the European Parliament and the Council as regularly as possible about fines which may be recorded as budgetary revenue, with a view to improving the predictability of Member States' contributions."

Statement by the Council and the Commission

"The Undersigned welcome the general approach reached by the Council on the Directive amending Directive 2011/16/EU as regards access to anti-money-laundering information by tax authorities. In order to make such access efficient and up-to-date, the Undersigned are of the opinion that Directive 2011/16/EC should be further revised and amended in the future, in order to take stock of the results of the ongoing revision of Directive (EU) 2015/849 on the prevention of the use of the financial system for the purpose of money laundering or terrorist financing, especially as regards automated centralised mechanisms such as central registries or central electronic data retrieval systems."
