THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 217, in conjunction with Article 218(5) thereof,

Having regard to the Act of Accession of the Republic of Croatia, and in particular Article 6(2) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) The Euro-Mediterranean Agreement establishing an Association between the European Communities and their Member States, of the one part, and the Hashemite Kingdom of Jordan, of the other part¹ ('the Agreement') was signed in Brussels on 24 November 1997 and entered into force on 1 May 2002.
- (2) The Republic of Croatia became a Member State of the European Union on 1 July 2013.
- (3) In accordance with Article 6(2) of the Act of Accession of the Republic of Croatia, the accession of the Republic of Croatia to the Agreement is to be agreed by means of a protocol to the Agreement concluded between the Council, acting on behalf of the Union and unanimously on behalf of the Member States, and the Hashemite Kingdom of Jordan.
- (4) On 14 September 2012, the Council authorised the Commission to open negotiations with the Hashemite Kingdom of Jordan. The negotiations were successfully concluded by means of an Exchange of Letters on 6 May 2014.
- (5) Article 7(3) of the Protocol provides for its provisional application before its entry into force.
- (6) The Protocol should be signed, subject to its conclusion at a later date, and applied on a provisional basis,

HAS ADOPTED THIS DECISION:

Article 1

The signing on behalf of the Union and its Member States of the Protocol to the Euro-Mediterranean Agreement establishing an Association between the European Communities and their Member States, of the one part, and the Hashemite Kingdom of Jordan, of the other part, to take account of the accession of the Republic of Croatia to the European Union is hereby authorised, subject to the conclusion of the Protocol.

The text of the Protocol is attached to this Decision*.

Article 2

The President of the Council is hereby authorised to designate the person(s) empowered to sign the Protocol on behalf of the Union.

Article 3

The Protocol shall be applied on a provisional basis, with effect from 1 July 2013, in accordance with Article 7(3) thereof, pending the completion of the procedures for its conclusion.
