Subject: Maltese Presidency - Chairing of certain Working Parties by delegations, at the request of the Maltese Presidency		

The Secretariat wishes to inform the Council that Malta, as holder of the Presidency for the period from 1 January to 30 June 2017, has requested, in accordance with Article 20(2) of the Council's Rules of Procedure, that the Netherlands and Slovakia chair certain Working Parties during this period on behalf of the Maltese Presidency, either for all meetings, for meetings covering certain topics which fall within their remit, or for meetings held outside Brussels.

The list below sets out these arrangements. It is suggested that the Council agrees to these arrangements in accordance with Article 19(4) of the Council's Rules of Procedure.

Furthermore, it should be noted that during the Maltese Presidency the High Level Working Group on Competitiveness and Growth (G.24) will be chaired by the Dutch representative to that Group, in accordance with the arrangements approved by the Permanent Representatives Committee on 31 October 2014 (15006/14).
