Subject: Working Party on Information of 25 November 2016

The meeting took place in the new EUROPA building. It was the first meeting of a Council's preparatory body held in the new facility.

1. Adoption of the agenda

The agenda was adopted as set out in document CM 4920/16.

2. Communication / Information Policy

a) European Council: information on working methods

<u>The Spokesperson of the President of the European Council</u> outlined Donald Tusk's ideas for new working methods as set out at the last meeting of the Heads of State or Government on 20 and 21 October 2016.

Reviewing a number of organisational aspects should enable the European Council to provide quicker responses to the recent crises. In doing so, there is a need to take due account of the following principles of the Bratislava Declaration:

- better and clearer communication with citizens, focusing on their expectations and contrasting rising populist forces;
- better management;
- refrain from mutual blame game and confirm loyal cooperation among Member States and between MS and the institutions, and *vice versa*.

Content-wise, there will also be a more consistent review of the implementation of the decisions taken at the European Council.

The proposed changes will also affect the practical handling of European Council meetings (one day only meetings; earlier time of press conference, better synchronised with national debriefings; and new practicalities for the photographic services).

b) "Europa" building: update

The General Secretariat of the Council recalled some key elements of the new building of the European Council and informed the WPI of the latest arrangements regarding the organisation of press activities (this part was complemented with a guided tour of the relevant press areas).

Moreover, the General Secretariat of the Council informed delegations about upcoming communication activities, including press and communication material to be released (a video to be released in 2017; a factsheet in all the EU languages etc.) and initial events foreseen in the new facility (a press visit on 7 December and guided tours for the general public on 10 December).

3. Transparency

a) Interinstitutional Agreement on a mandatory Transparency Register

State of play

<u>The WPI</u> was informed that on 18 November 2016 the General Affairs Group discussed the draft reply to the letter of First Vice-President Frans TIMMERMANS addressed to Mr Ivan KORČOK, President in Office of the Council (14209/16). There were no objections from the delegations, therefore, the reply letter should be submitted to Coreper for endorsement on 30 November.

b) Questionnaire on LIMITE documents

The General Secretariat presented document 14352/16 summarising the main elements and results of the questionnaire on issuing LIMITE documents sent to GSC departments in June.

<u>The General Secretariat</u> also informed delegations that, as part of a broader reflexion exercise on Transparency currently pursued by the General Secretariat, an examination on whether and at what point in time a "LIMITE" document could be released to the public is being conducted.

<u>The Chair</u> concluded that this item will be included in the WPI agenda at one of the its next meetings.
