Subject:	Proposal for transfer of appropriations No DEC 1/2016 within Section VII - Committee of the Regions - of the general budget for 2016

 On 3 November 2016, the <u>Committee of the Regions</u> submitted to the Council proposal for transfer of appropriations No DEC 1/2016.

The purpose of this proposal is to transfer a global amount of EUR 935 880 from Items 1004 (*Travel and subsistence allowances, attendance at meetings and associated expenditure*), 1420 (*Supplementary services for the translation service*), 1422 (*Expert assistance related to consultative work*) and 2026 (*Security and surveillance of buildings*) to Item 2001 (*Annual lease payments*).

- 2. The Committee of the Regions proposes to transfer unused appropriations of its 2016 budget to the line covering annual lease payments. The aim of this operation is to free appropriations on this line in the 2017 budget which, in turn, could be used to finance the security refurbishment of the Jacques Delors building entrance hall.
- 3. The <u>Budget Committee</u> examined this proposal for a transfer at its meetings on 21 and 29 November and on 2 December 2016.

- 4. Following that examination, the Budget Committee did not reach a position on the proposal for a transfer, as there was no qualified majority neither to approve nor to refuse it, in line with Article 27 of the Financial Regulation.
- 3. The Permanent Representatives Committee is invited to advise the Council to take note and to:
  - approve the draft letter in ANNEX 1 to that effect;
  - enter in its minutes the unilateral statement by Austria, Belgium, Bulgaria, Croatia,
    Cyprus, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Hungary,
    Ireland, Latvia, Lithuania, Malta, the Netherlands, Poland, Portugal, Romania, Slovakia,
    Slovenia, Spain, Sweden and the United Kingdom recorded in ANNEX 2.
