MB-16-29 Unanimous decision to agree on the maximum number of candidates (3) to be put on the list to be proposed to the Council for the appointment of a Chairperson of a Board of Appeal. MB-16-30 Unanimous decision to adopt the draft list of non-valid applications proposed by the Preparatory Subcommittee in the procedure (Reference VEXT/16/120/AD 13/BOA Chairperson), for the appointment of a Chairperson of a Board of Appeal.
- MB-16-31 Unanimous decision to adopt the draft list of admissible candidates proposed by the Preparatory Subcommittee in the procedure (Reference VEXT/16/120/AD 13/BOA Chairperson), for the appointment of a Chairperson of a Board of Appeal.
- MB-16-32 Decision to agree on the draft list of candidates proposed by the Preparatory Subcommittee and subsequent adoption of the list of three candidates for the post of Chairperson of a Board of Appeal to be proposed to the Council, for the procedure with reference VEXT/16/120/AD 13/BOA Chairperson. The decision was taken by a majority of two thirds of the Members with 30 votes in favour and 1 abstention.
- MB-16-33 Unanimous decision on the reclassification from grade AD11 to AD12 of the member of the Boards of Appeal of the Office, Mr Cornelis Johannes Govers.

- MB-16-34 Approval of the draft decision, as amended, delegating the powers conferred by the Staff Regulations on the appointing authority and by the Conditions of Employment of Other Servants of the European Union on the authority authorised to conclude contracts of employment to the Executive Director of the European Union Intellectual Property Office, and decision to empower the Executive Director to submit this draft decision for the Commission's agreement in accordance with the procedure laid down in Article 110 Staff Regulations. The decision was taken by a majority of two-thirds of the Members with 23 votes in favour
- MB-16-35 Unanimous decision to approve the launch of a written procedure once the Office has received the agreement of the Commission under Article 110 of the Staff Regulations regarding the draft decision delegating the powers conferred by the Staff Regulations on the appointing authority and by the Conditions of Employment of Other Servants of the European Union on the authority authorised to conclude contracts of employment to the Executive Director of the European Union Intellectual Property Office.
- MB-16-36 Decision taken to determine the distribution key to be applied to the offsetting of costs within the meaning of Article 139(5) EUTMR, starting by distributing an initial 2 % of the total amount to each of the Member States and then distributing the remaining by giving the same weighting to each of the four indicators (25 % each). The decision was taken by an absolute majority of two thirds of the Members with 23 votes in favour.
- MB-16-37 Unanimous decision to revisit the distribution key after three years of effective application.
- MB-16-38 Favourable opinion on the Office's trade mark and design practice as reflected in the draft Guidelines, so that the Executive Director of the Office can formally adopt the Guidelines as required by Article 124(1)(I) EUTMR and Article 101(b) CDR.
- MB-16-39 Decision taken to invite representatives of the EUIPO Staff Committee to attend the meeting of the Management Board during discussions on matters not considered to be confidential.



According to the EU trade mark Regulation, as last-amended by Regulation (EU) 2015/2424 of the European Parliament and of the Council of 16 December 2015, the Council appoints the Executive Director of the EU Intellectual Property Office (EUIPO), his/her Deputy(ies), the President of the Boards of Appeal and the chairpersons of the Boards of EUIPO in accordance with the procedure set out in Art. 129(2) of the said Regulation.

The latter provides inter alia that the Council decides from a list of candidates proposed by the Management Board of the EUIPO and that <u>before being appointed</u>, the <u>candidate selected by the Management Board "may be invited to make a statement before any competent European Parliament committee and to answer questions put by its members."</u>
