#### Whereas:

- (1) Pursuant to Council Decision (EU) 2016/...<sup>1\*</sup>, the Framework Agreement between the European Union and its Member States, of the one part, and Australia, of the other part ('the Agreement') was signed on ..., and some of its provisions are being applied on a provisional basis in accordance with Article 61 of the Agreement, pending its entry into force.
- The objective of the Agreement is to strengthen the cooperation across a wide spectrum of policy fields, including human rights, non-proliferation of weapons of mass destruction, the fight against terrorism, cooperation on economic and trade matters, health, the environment, climate change, energy, education, culture, labour, disaster management, fisheries and maritime affairs, transport, legal cooperation and the combating of money laundering, terrorist financing, organised crime and corruption.
- (3) The Agreement should be approved,

#### Article 1

The Framework Agreement between the European Union and its Member States, of the one part, and Australia, of the other part is hereby approved on behalf of the Union<sup>1\*</sup>.

#### Article 2

The President of the Council shall, on behalf of the Union, give the notification provided for in Article 61(1) of the Agreement<sup>2</sup>.

#### Article 3

The High Representative of the Union for Foreign Affairs and Security Policy shall co-chair the Joint Committee provided for in Article 56 of the Agreement.

The Union or, as the case may be, the Union and the Member States, shall be represented in the Joint Committee, depending on the subject matter.

The Agreement has been published in the *Official Journal of the European Union* (OJ L ..., p. ...) together with the Decision on the signing and provisional application thereof.

The date of entry into force of the Agreement will be published in the *Official Journal of the European Union* by the General Secretariat of the Council.
