The Council held a public exchange of views on the agricultural aspects of the proposals on the Effort Sharing Regulation and on the LULUCF Regulation on the basis of a Presidency note as set out in 14970/16. The delegations were of the view that in preparation of these proposals, the Commission has generally followed the guidance given by the European Council Conclusions of 2014. However, they stressed the importance of food security and the need to achieve the climate objectives in a way that does not jeopardise sustainable food production. Several delegations were of the view that flexibilities in these proposals could be more balanced. It was acknowledged that agriculture is a victim of climate change but can be also part of the solution, especially when using new technologies.

The Council took note of the comments made by the delegations and the Commission.

The President of the "Agriculture and Fisheries" Council will send a letter to the President of the "Environment" Council, summarising the outcome of the debate.
