## Joint statement by Poland, Germany, Denmark and Luxembourg

"The Polish, German, Danish and Luxembourg delegations take note of the conclusion of the agreement in the first reading between the European Parliament and the Council on a *Proposal for a Directive of the European Parliament and of the Council amending Directive 2007/36/EC as regards the encouragement of long-term shareholder engagement* and commend successive Council presidencies for their efforts aimed at achieving a balanced compromise on the proposal.

In line with the positions presented during the work on the proposal, the Polish, German, Danish and Luxembourg delegations interpret the provision of Article 3f paragraph 1 point a) of a *Proposal for a Directive of the European Parliament and of the Council amending Directive 2007/36/EC as regards the encouragement of long-term shareholder engagement* on the content of the policy of shareholder engagement as allowing institutional investors and assets managers to formulate the engagement policy in a way that they may choose the matters on which they monitor the investee companies and they are not obliged to address in the engagement policy specifically each of the matters referred to in Article 3f paragraph 1 point a) of the proposal.

In the opinion of our delegations, the agreed text of the third sentence of recital 11 of the abovementioned proposal, which states: "*The policy on shareholder engagement should describe how institutional investors and asset managers integrate shareholder engagement in their investment strategy and which different engagement activities they choose to carry out and how they do it.*", confirms the correctness of this interpretation."

## Statement by Luxembourg

"Luxembourg fully supports the objective of the Directive of the European Parliament and of the Council amending Directive 2007/36/EC as regards the encouragement of long-term shareholder engagement to encourage the long-term engagement of the shareholders and to enhance transparency of institutional investors and asset managers. At the same time, as stated in the recitals, the Directive should be without prejudice to the provisions laid down in sectoral EU legislation regulating specific types of listed companies or specific types of entities, such as credit institutions, investments firms, asset managers, insurance companies and pension funds.

Consequently, it is the understanding of Luxembourg that with regard to articles 3g and 3h of the Directive where assets of an institutional investor are not managed on an individual basis but pooled together with assets of other investors and managed via a collective investment undertaking, the sectoral legislation applicable to collective asset management should prevail over the Directive to the extent that the requirements provided by the Directive contradict the requirements laid down in sectoral EU legislation. For example, the Directive should be without prejudice to the provisions governing the diversification of the portfolio of collective investment undertakings and the prohibition to acquire any shares carrying voting rights which would enable collective asset managers to exercise significant influence over the management of an issuing body."

#### Statement by Slovenia

"The Republic of Slovenia reaffirms its commitment to implement the provisions of the Schengen Border Code (hereinafter the Code) introducing strengthened checks on persons crossing the external borders of Member States, also on those enjoying the right of free movement under Union law. While the purpose of exercising border checks in this manner is expected to deliver an improvement to control of external borders, to increase Member States' internal security and to prevent terrorism, this will also have other consequences. By this declaration, Slovenia wishes to draw attention to the potential consequences that will follow from consistent implementation of Article 7(2) of the Code.

The Republic of Slovenia, as a country whose territory is one of the most heavily burdened entry and exit areas enabling access to Member States<sup>1</sup>, is fully aware of its responsibility of carrying out border control in the interest of all Member States. In Slovenia's view, checks carried out systematically on all persons crossing the external borders, including those enjoying the right of free movement under Union Law, without targeted checks as a basic principle for efficient border checks and without taking into consideration justified exemptions, is a disproportionate measure in relation to the pursued objective of the change. Additional doubts to the efficiency of the new provisions of Article 7(2) of the Code are related to the possible transitional period for border checks at air borders that are especially vulnerable part of the external borders.

The implementation on the scale as specified in Article 7(2) of the Code will have an adverse effect on passenger flows at external borders as it will also have financial implications for Member States. Slovenia cannot be held ultimately accountable for such outcomes.

Slovenia also welcomes the intention of the European Commission to assess regularly the implementation of the Code, including the consequences of amended provisions, and propose relevant amendments if necessary."

### Statement by Hungary

"Hungary welcomes the agreement reached on the Regulation of the European Parliament and of the Council on Money Market Funds. Recital (24a) and Article 14(1)b of the Regulation cater for the specificities of small Member States and provide flexibility in terms of an increase in the diversification limit when the MMF invests its assets in deposits made with the same credit institution. Accordingly Hungarian MMFs may apply the 15% diversification limit for these investments."

### Statement by Luxembourg

"Luxembourg supports the overall objective of the money market funds regulation to make all categories of MMFs safer and more robust, given the key role MMFs play in the financing of the real economy.

The situation of MMFs that are exclusively distributed to investors outside of the EU and of MMFs that are structured as master-feeders is not properly addressed by the political agreement.

A quota of EU-debt for public debt CNAV MMFs as referred to in the review clause is legally disputable, sets a questionable precedent and will ultimately hinder the development of this new category of MMFs. Such an EU-centred approach ignores that the success story of the EU asset management industry is largely due to its global perspective.

The political agreement is likely to jeopardize the viability of some categories of MMFs in the long run, and hence bears the risk of making valuable market-based sources of financing disappear. This runs counter the objectives of the Capital Markets Union. Luxembourg does therefore not support the political agreement reached on the regulation on money market funds."

### Statement by Greece

"On November the 9th 2016 the presidency as a result of discussions with Member States ended up with a compromise proposal on MMF Regulation. Article 14-para-1 point b of the regulation was, inter alia, an issue of the compromise. In particular the percentage of a MMF assets in deposits made with the same credit institution was agreed to reach the figure of 15% under particular circumstances. That figure is the minimum acceptable in the Greek market which is characterized by its small and highly concentrated banking sector. However, after the fifth trilogue meeting of 14.11.2016, the presidency presented a new text which imposed a new cumulative condition that in effect limits the discretion of the MMF incorporated in a member state with highly concentrated banking sector to deposit up to 15% of their assets to the same credit institution. We have therefore serious concerns regarding the new drafting of article 14(1)(b) of the MMF Regulation."

Joint statement by Luxembourg, Ireland and the Netherlands

"Luxembourg, Ireland and the Netherlands are convinced that the security-development nexus needs to be addressed by capacity building measures, to be financed in the short term through an amended Instrument contributing to Stability and Peace. In our view, funds provided from ODA eligible instruments for the financing of actions undertaken in conformity with art. 3a of the present regulation amending regulation 230/2014 should be used in compliance with the OECD DAC criteria as set out in the reporting directives on Official Development Assistance from February 19th 2016."

Statement by Sweden

"Sweden's Declaration on the Council Position regarding the Proposal for a Regulation of the European Parliament and of the Council amending Regulation (EU) No 230/2014 of the European Parliament and of the Council of 11 March 2014 establishing an Instrument Contributing to Stability and Peace

Sweden strives for an efficient and fully operational solution to CBSD.

Sweden regrets that the current amendment of the Instrument contributing to Stability and Peace does not respect the ODA-criteria, agreed in the OECD/DAC in February 2016. The proposal's definition of development cooperation with respect to "building capacity of military actors in partner countries under exceptional circumstances" goes far beyond the ODA-criteria, which only allow for support to the military in clearly specified limited areas. Protecting the development budgets and their use, secured through the respect for the OECD/DAC rules, is of utmost importance. Thus, Sweden would have liked to see a clear reference in the amendment to the reporting directives on ODA in the field of peace and security.

Sweden fully recognizes the close interrelationship between development and security, acknowledging the importance of adequate funding for measures contributing to security and stability – a pre-requisite for sustainable development. However, blurring the boundaries of development cooperation and security-related activities will not provide a sustainable solution. In the long run we risk undermining the development agenda, as well as the effectiveness of the CBSD."

#### Statement by Italy

"Italy is fully committed to implement the priorities set by the European Council in its conclusions of October 2016, i.e. that unfair trade practices must be countered effectively and vigorously in order to 1) safeguard European jobs and 2) ensure fair competition in open markets and preserve free trade. It is, therefore, of crucial importance that the EU is provided with effective trade defence instruments able to counter the distortive effects of ruthless globalization and at the same time promote a fair and inclusive growth.

Italy has worked hard both in the course of this year and in its six-month presidency in 2014 looking for a balanced compromise on the TDI regulation and although we highly appreciate the efforts made by the current Presidency, we consider the current proposal a downgrading of the Trade Defence Policy as such, with negative effects on the European and Italian industry. The call made in the October EC conclusions, that was a precondition for a balanced compromise, seems not to have been taken into account and, as repeatedly stated, this final proposal is insufficient to protect the legitimate rights of European manufacturing and inadequate to guarantee a real modernisation, for the following reasons:

- The disapplication of LDR is very limited and complicated in its structure and uncertain in its implementation.
- Several other elements such as reimbursement, pre-disclosure, limitations to the ex-officio launch of new investigations tend to favour market diversion phenomena (stockpiling) or to limit the collection of AD and AS duties, reducing the actual effectiveness of TDIs.
- Other aspects, although in principle useful, risk being ineffective (aid to small and medium-sized enterprises, the level of the target profit, etc.), as they are either already applied by the Commission or insufficient to generate substantial results.

At this stage an impact study would be needed to demonstrate the effects of the proposal on the current cases (in particular to demonstrate how the disapplication of the LDR would work in the cases already in place and what the effect on the growth of average duties would be). We also noted that the comments submitted by Italy (most recently by m.d. 149/16), a large manufacturing country, have not been taken into account.

In the light of these considerations and having in mind a serious and balanced modernisation of TDI, Italy cannot accept this compromise. In any case, we will be always ready to fully engage during the trilogue so that the current unsatisfactory text can be suitably improved."

"Notwithstanding its consent to the Screening Report for Chapter 27, Croatia emphasizes the need to maintain consistency of the policy approach vis-a-vis candidate countries with the similar level of preparedness for the transposition and the implementation of the acquis, in the present and in the previous rounds of enlargement.
