Council statement on the presentation of the Commission's statement of estimates for 2017

The Council recalls the pragmatic calendar agreed between the Council, the European Parliament and the European Commission during their trilogue on 14 March 2016 setting the dates for the budgetary procedure for 2017. This pragmatic calendar is an essential element for the improvement of the functioning of the budgetary procedure and contributes to ensuring a timely adoption of the budget, in keeping with the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management.

An early presentation of the statement of estimates by the Commission is important in order to allow enough time for the Council to undertake a detailed technical analysis of the estimates transmitted, to maintain a balance in respect of the time available for each institution and ensure that the timings set out in the pragmatic calendar are maintained.

The Council calls on the Commission to ensure a timely presentation of the statement of estimates for the budget in future years in line with the good practice established in the previous years and in keeping with the aim of the Interinstitutional Agreement to ensure the proper functioning of the annual budgetary procedure.

Council statement on payment appropriations

The Council will carefully examine the letter of amendment for agriculture (including information on assigned revenue) in order to appropriately assess the level of resources under heading 2 (Sustainable growth: natural resources) in the 2017 budget.

The Council calls on the Commission to continue closely scrutinizing the implementation of the 2014-2020 programmes. To that end, it invites the Commission to present in a timely manner updated figures concerning the state of affairs and estimates regarding 2017 payment appropriations with a view to allowing the budgetary authority to take any necessary decisions in due time for justified needs.

Council statement on the 5 % staff reduction

The Council recalls the agreement reached between the European Parliament, the Council and the Commission to progressively render 5 % of the staff as in the establishment plan on 1 January 2013, to be applied to all institutions, bodies and agencies and to be effected between 2013 and 2017, as inscribed in Point 27 of the Interinstitutional Agreement of 2 December 2013 on budgetary discipline, on cooperation in budgetary matters and on sound financial management.

The Council takes note of the Commission's monitoring of the progress towards the 5 % staff reduction target achieved to date by the institutions, as presented in the table in Appendix 1. It invites the Commission to provide also comparable global data for decentralised and executive agencies in that presentation.

The Council recalls that the target year for the full implementation of the 5 % reduction of staff is 2017. It is highly dissatisfied that not all institutions, bodies and agencies will achieve the implementation of the 5 % staff reduction in time by the end of 2017 and insists that appropriate follow-up measures be taken immediately to take stock of the situation with a view to ensuring that all efforts are deployed to avoid any additional delays in implementing the 5 % staff reduction target for all institutions, bodies and agencies.

The Council also underlines the importance of monitoring closely the appropriations for all categories of external staff, against the backdrop of the additional capacity built up by the increase of working time to 40 hours per week. It welcomes the Commission's overview of consolidated data on all external staff employed by the institutions, presented in Appendix 2, in line with point (b) of Article 38(3) of the Financial Regulation. It invites the Commission to continue providing this information to the budgetary authority when presenting its draft budgets for future years.

The Council underlines that achieving the 5 % staff reduction target should contribute to savings in the institutions' administrative expenditure. With that in mind, it invites the Commission to start assessing the outcome of the exercise in order to draw lessons for the future.

Statement by Croatia

Regarding Recital 60, following discussions within the Council and based on the opinion of the Council Legal Service, Croatia considers the references to Title II of Regulation (EU) No 2016/399 as well as to the Protocol 19 on the Schengen acquis integrated into the framework of the European Union apply to Croatia.

Statements by Germany

1. With regard to Article 56(3) of the proposal for a Regulation of the European Parliament and of the Council on the European Border and Coast Guard and repealing Regulation (EU) No 2007/2004, Regulation (EU) No 863/2007 and Council Decision 2005/267/EU, Germany recalls paragraph 8 of the Joint Statement of the European Parliament, the Council of the EU and the European Commission on decentralised agencies according to which the host State should commit itself to [continue to] respond to the agency's needs and provide the necessary conditions for the smooth operation of the agency[, also after the latter has been set up]. Germany considers itself bound by this, so its agreement to the current wording should therefore not be seen as a precedent for the future foundation of (new) agencies, and it would ask the Commission to take this into account in the future when preparing comparable proposals.

2. The Federal Government continues not to share the Commission's view that Article 8(6) of Directive 2008/115/EC of the European Parliament and of the Council of 16 December 2008 on common standards and procedures in Member States for returning illegally staying third country nationals (the 'Return Directive') requires (explicit) transposition into German law. Germany already has an effective forced return monitoring system. Administrative and technical monitoring of forced returns may also be carried out by the immigration authorities, the federal and state police forces, as well as through judicial review by independent courts.

The wording of Article 8(6) of the Return Directive was intentionally broad, and nothing within those provisions obliges Member States to establish an independent monitoring body. Had that been the intention when drafting the Directive, the text could have included such an additional provision. As the Commission itself stated in its letter of 16 October 2014, the essential feature of forced return monitoring arrangements is examination by third parties that are not directly involved in the return process. This applies at least to judicial review of forced returns. Moreover, Article 8(6) refers to 'forced return monitoring', not forced return 'observation'. Therefore, monitoring may also take place by the courts after the event, for example following an appeal.

In addition to judicial and administrative review, various non governmental and church organisations keep a watch on removals and forced returns at key German airports on a voluntary basis. While Germany's authorities basically welcome these organisations' committed involvement in this area, there is no obligation to facilitate such activities, nor is it necessary given the existing monitoring options described above.

Statement by Romania Romania underlines the importance of the Framework Agreement in consolidating and deepening the political dialogue and cooperation in various fields of mutual interest between the European Union and Australia. Romania recalls the EEAS' commitment to raise at the level of the Joint Committee to be established by the Agreement, aspects of particular interest highlighted by several Member States during the negotiation process of the Agreement, among which the importance of ensuring full visa reciprocity, as highlighted by Romania. We underline that this issue remains a priority and a matter of concern for Romania, considering that Australia continues to apply a different treatment for Romanian citizens in the process of visa granting, translated into a significantly lower rate of autogrant visa in the case of Romanian citizens compared to the other EU citizens. We expect the EEAS to raise our concerns within the Joint Committee after the signing of the Agreement and inform us accordingly on the outcome of the discussions.
