# **COUNCIL DECISION (EU) 2016/**

# appointing two members and two alternate members, proposed by the Slovak Republic, of the Committee of the Regions

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to the proposal of the Slovak Government,

#### Whereas:

- On 26 January 2015, 5 February 2015 and 23 June 2015, the Council adopted Decisions (1) (EU) 2015/116<sup>1</sup>, 2015/190<sup>2</sup> and 2015/994<sup>3</sup> appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2015 to 25 January 2020.
- (2) Two members' seats on the Committee of the Regions have become vacant following the end of the terms of office of Mr Vladimír BAJAN and Mr Peter CHUDÍK.
- An alternate member's seat on the Committee of the Regions has become vacant following (3) the end of the term of office of Mr Radoslav ČUHA.
- An alternate member's seat on the Committee of the Regions has become vacant following (4) the appointment of Mr Ján FERENČÁK as a member of the Committee of the Regions,
