Following discussions in the Permanent Representatives Committee (Part 1) on 2 October 1996, the Presidency proposes that Annexes II and III to 10121/96 be replaced by Annexes I, II and III attached hereto.

Draft Council decision authorizing the Commission to open negotiations on the participation of the Community in the Diplomatic Conference to be held in Geneva from 2 to 20 December 1996 under the auspices of the World Intellectual Property Organization and to draw up a treaty on certain questions concerning the protection of literary and artistic works

The Council decides that in the course of the preparatory work and of the Diplomatic Conference to be held under the auspices of WIPO in Geneva from 2 to 20 December 1996 with a view to drawing up a treaty on certain questions concerning the protection of literary and artistic works, (1) the Commission is authorized to negotiate, in consultation with the special committee appointed by the Council to assist it and in accordance with the negotiating directives appended hereto, in matters coming within the scope of Community competence as indicated by the provisions of the directives (2) and the right of the Community to accede to the future Treaty. The Commission will ensure that the views of the Member States will be duly taken into consideration during the negotiations.

⁽¹⁾ The negotiations include the *sui generis* protection of databases, which does not come within copyright and related rights and which should be covered by a separate instrument. This is without prejudice to the decision on the instrument which will finally be selected as the vehicle for the provisions on this topic.

Negotiating directives

1. Participation of the Community in the future treaty

The negotiations will be directed to securing the incorporation in the treaty on certain questions concerning the protection of literary and artistic works envisaged by WIPO of provisions enabling the Community to become a contracting party to the treaty and, in order to exercise its voting right in matters coming within the scope of Community competence, to have a number of votes equal to the number of Member States of the Community which are parties to the treaty.

2. Content of the future treaty

The Commission will conduct negotiations, in consultation with the special committee appointed by the Council to assist it, to ensure that the future provisions conform with Council Directive 91/250/EEC, 92/100/EEC, 93/83/EEC, 93/98/EEC and 96/9/EC and with the commitments entered into by the Community and the Member States within the framework of the Agreement on Trade-Related Aspects of Intellectual Property Rights.

Statement by the Council, the Commission and the Member States for the Council minutes

In accordance with the obligation of cooperation between the Member States and the Community institutions laid down, inter alia, in Opinion 1/94 of the Court of Justice, the Council, the Commission and the Member States agree that, since the subject-matter of the proposed treaties falls in part within the competence of the Community and in part within that of the Member States, the Commission and the Member States will coordinate through meetings in the Council bodies, or organized on the spot if necessary, concerning the position to be adopted in the Diplomatic Conference.
