The SCA took note of the presentation by the Commission of the consultation on modernising and simplifying the CAP as well as of delegations' questions and Commission's replies. In its intervention, the Cypriot delegation requested to have a discussion at the SCA meeting of 27 February on the implications of the "Implementation of the 2030 Agenda for Sustainable Development in European Agriculture".

Also in the context of the CAP post-2020, the SCA discussed two special reports of the Court of Auditors (ECA) on the Land Parcel Identification System (LPIS) and cross-compliance and noted a number of textual suggestions by delegations, which could be considered further by the AGRIFIN Working Party in the finalisation of the draft Council conclusions on these two reports.
