Information from the General Secretariat of the Council - State of play

The Working Party (WPI) was informed of the outcome of the meetings of the General Affairs Group (GAG) on 27 January and 10 February 2017 concerning the opinion of the Council Legal Service (CLS). A majority of delegations in the GAG were in favour of more transparency but acknowledged the legal obstacles raised in the CLS opinion. The Presidency would prepare a paper on the follow-up to the discussions on the IIA which would continue in forthcoming GAG meetings.

## b) European Ombudsman

i) Own-initiative inquiry OI/8/2015/JAS concerning the Transparency of Trilogues: follow-up

The GSC informed the Working Party of the receipt of a follow-up letter from the Ombudsman requesting to be informed by the end of November 2017 of the progress made regarding her proposals to increase the transparency of trilogues and of the conclusions drawn by the Council from the ruling in the case pending before the General Court about the 4-columns document. Her particular interest in the development of the joint legislative database provided in the Interinstitutional Agreement on Better Law-Making was also highlighted in the letter.

### b) Delegates Portal survey

WPI delegates were called upon to participate in the anonymous online customer satisfaction survey on Delegates Portal which would be available shortly. The aim of this survey is to receive feedback in order to assess to what extent the portal meets current business requirements and, where necessary, to improve or broaden its functionalities.

# c) Court cases (new item)

Upon request of a delegation, the representative of the Legal Service explained that the possibility of intervening in cases T- 851/16 and T-852/16 had been considered but, taking into account the fact that only Commission documents were concerned, it had been ruled out in conformity with Council practice.
