Mr Engel (EPP, LU) presented the delegation report from Bulgaria visit and emphasised that situation was improving on the ground. However should the refugee numbers further increase, the Bulgarian authorities would have difficulties in coping. He stressed that the Syrian refugee crisis was a European problem that needed to be addressed jointly, in particular given that the situation

6922/14 PT/aa 6 DRI **EN**  could further deteriorate. Mr Iltchev (ALDE, BG) raised the issue of large numbers of unaccompanied minors. Mr Stoyanov asked the Commission to explain how it funded measures to alleviate the Syrian refugee crisis in Bulgaria. The Commission representative explained that funds were coming from multiple sources, including Member States, the EU budget, and from development assistance, the refugee fund and border fund. The Commission shared the concerns over the situation of refuges in Bulgaria and explained that should the Commission propose in future to activate the Dublin Article 32 mechanism this would be with the aim of supporting Bulgaria.
