Subject:	Draft amending budget No 1 to the general budget for 2017 accompanying the proposal to mobilise the European Union Solidarity Fund to provide assistance to the United Kingdom, Cyprus and Portugal

1. On 26 January 2017, the <u>Commission</u> submitted to the Council draft amending budget (DAB) No 1 to the general budget for 2017 regarding the mobilisation of the EU Solidarity Fund for a total amount of EUR 71 524 810 in commitment (c/a) and payment appropriations (p/a).

The objective of this proposal is to provide financial assistance to the United Kingdom, Cyprus and Portugal in response to natural disasters that hit those countries in 2015 and 2016.

The corresponding appropriations are to be recorded under Article 13 06 01 (*EU Solidarity Fund - Assistance to Member States in the event of a major natural disaster with serious repercussions on living conditions, the natural environment or the economy*). The Commission proposes to finance the necessary p/a by making use of the negative reserve, as provided for in Article 47 of the Financial Regulation.

2. The Budget Committee examined DAB No 1/2017 at its meeting on 31 January.

During this examination, the Budget Committee noted that advances paid to Cyprus and Portugal in the framework of this mobilisation were not deducted by the Commission from its financing proposal.

Therefore, the <u>Presidency</u> proposed to amend DAB No 1/2017 accordingly and to subtract the advances paid. An amount of EUR 1 122 376 is therefore subtracted in c/a and p/a from DAB No 1/2017, which, as amended, stands at EUR 70 402 434 instead of EUR 71 524 810.

The Budget Committee examined this Presidency proposal at its meeting on 13 February and was able to accept it.

- 3. At the close of its examination, the <u>Budget Committee</u> agreed to suggest that the Permanent Representatives Committee advises the Council to:
 - adopt the Council's position on DAB No 1/2017 as set out in point 2;
 - instruct the Presidency to prepare the budgetary documents to be sent to the
 European Parliament and to approve the draft letter in Annex 2 to that effect;
 - have the Council's position published in the Official Journal of the European Union as set out in Annex 1.
