Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union<sup>2</sup>, and in particular Articles 23 and 24 thereof.

### Whereas:

- In its Decisions of 20 September 2016<sup>3</sup>, 14 November 2016<sup>4</sup> and 28 November 2016<sup>5</sup>, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2018.
- (2) A seat as member in the employers' representatives category has fallen vacant as a result of the resignation of Mr Alexander WILHELM.
- (3) The Government of Germnay has submitted a nomination for the vacant seat,
