THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union², and in particular Articles 23 and 24 thereof.

Whereas:

- In its Decisions of 20 September 2016³, 14 November 2016⁴ and 28 November 2016⁵, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers for the period ending on 24 September 2018.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr George SPYROU.
- (3) The Government of Cyprus has submitted a nomination for the vacant seat,
