Subject:	Draft Council Decision appointing five members and five alternate members, proposed by the United Kingdom, of the Committee of the Regions
	- Adoption

- 1. By letters dated 14 December 2015, 7 January 2016 and 19 May 2016, the Secretary-General of the Committee of the Regions notified the Council of the resignation Mr Mick ANTONIW and the end of mandates of Mr Roger EVANS, Mr Stewart MAXWELL, Ms Patricia FERGUSON and Mr Gordon KEYMER, members of the Committee of the Regions, as well as of the resignation of Mr Robert John PRICE and the end of mandates of Mr Jim HUME, Mr Rhodri Glyn THOMAS and Mr James MCGRIGOR, alternate members of the Committee of the Regions¹.
- An alternate member's seat will become vacant following the appointment of Ms Jennette ARNOLD as member of the Committee of the Regions.
- 3. Under Article 305 TFEU, members and alternate members of the Committee of the Regions are appointed by the Council, acting by a qualified majority on proposals from the respective Member States.

The Permanent Representatives Committee is therefore asked to suggest that the Council adopt the Decision set out in 7412/17 CDR 47 as an 'A' item at a forthcoming meeting. 6.
