The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

In addition, we have identified an internal GSC note of 22 October 2015 to the Secretary-General on the issue of *safe harbour*.

I regret to inform you that access to this latter document cannot be given for the reasons set out below.

This document contains internal information and assessments concerning negotiations with the United States of America on this issue. Its release would prejudice relations with the USA and weaken the EU's position vis-à-vis that country.

Disclosure of the document would therefore undermine the protection of the public interest as regards international relations. As a consequence, the General Secretariat has to refuse access to the document.²

You can ask the Council to review this decision within 15 working days of receiving this reply (confirmatory application).³

Subject: Internal review of access to documents request - Request for Privacy Shield Records

Dear Council of the EU,

Please pass this on to the person who reviews confirmatory applications.

I am filing the following confirmatory application with regards to my access to documents request 'Request for Privacy Shield Records'.

The Council of the EU is illegally withholding access to a public document. The public document is mentioned in the Secretariat General's letter dated 14 March 2017. The public document in question is GSC note 22, dated 22 October 2015 to the Secretariat General on the issue of safe harbour. The Secretariat General is claiming that the release of this GSC note 22 would undermine the public interest as regards to international relations.

Release of this public document, GSC note 22, is in the public interest. The public has a right to know the details of negotiations between the US and the EU on the issue of safe harbour. The issue of safe harbour, data transfers from the EU to the US, deals with people's fundamental rights under the European Charter of Fundamental Rights of the EU. The public has a right to know the EU's position and its negotiations with the US in the protection of personal data, which is a guaranteed fundamental right under Article 8 of the European Charter of Fundamental Rights of the EU.
