Subject:	Ad hoc release of classified documents to the Court of Auditors

- In the context of an audit of the CSDP Mission EUCAP Sahel Niger Operational Plan (OPLAN), the Court of Auditors has requested to the EEAS the release of three classified documents originated in the GSC :
 - Note from the Council to the PSC (ST 10002/16 of 10/06/2016, classified RESTREINT UE/EU RESTRICTED);
 - Note from the Council to the PSC (ST 11107/15 of 22/07/2015, classified RESTREINT UE/EU RESTRICTED);
 - Note from the General Secretariat of the Council to Delegations (ST 5433/13 of 21/01/2013, classified RESTREINT UE/EU RESTRICTED).

These documents relate to the Operational Plan (OPLAN) of the Mission referred to. An authorisation for an *ad hoc* release is required as there are no arrangements in place for sharing classified information with the Court of Auditors.
