We have registered your request of 23 January 2014 for access to document 11914/13. Thank you for your interest.

The General Secretariat of the Council has examined your request on the basis of Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents¹ (hereafter the "Regulation") and specific provisions of the Council's Rules of Procedure² and has come to the following conclusion:

Document 11914/13 is a note from the General Secretariat to the Working Party for Schengen Matters (SIS/SIRENE) / Mixed Committee (EU-Iceland/Norway/Switzerland/Liechtenstein) and contains tables of hits recorded by the SIRENE Bureaux during the period 1.1.2012-31.12.2012.

These tables contain details on the exchange of information by the SIRENE Bureaux. This information, if disclosed, would undermine public security as it could be exploited by individuals involved in various forms of organised crime in order to undermine the functioning of the SIRENE network, a network which is essential in maintaining a high level of security within the area of justice, freedom and security. Accordingly, pursuant to Article 4(1)(a), first indent of the Regulation (protection of the public interest with regard to public security), the General Secretariat is unable to accede to your request.

As the exception to the principle of transparency applies to the content of the entire document, the General Secretariat is unable to grant you partial access as provided for in Article 4(6) of the Regulation.

With the above mentioned letter, you denied my request to access to document ST 11914 2013 INIT (Table of hits recorded by the SIRENE Bureaux Period : 1 January 2012 to 31 December 2012), your reasons being, that it would endanger public security.

With this confirmatory letter, I am requesting you, to reconsider your position, since all previous versions of this document, e.g. ST 7389 2013 INIT, ST 8281 2012 INIT, containing the same information on the number of hits recorded by the SIRENE Bureaux in each period, were readily accessible.

I am only interested in the number of hits recorded by the SIRENE Bureaux in 2012, no other information is required.

Therefore, under Article 7(2) of Regulation (EC) No. 1049/2001 I am requesting the Council to reconsider its position on denying me access to document ST 11914 2013 INIT.

Thank you for your message dated 3 February 2014.

With your message, you introduce a confirmatory request for access to document 11914/13 (Table of hits recorded by the SIRENE Bureaux during the period 1 January 2012-31 December 2012). You ask the Council to reconsider its position relating to the above-mentioned document, indicating that all previous versions of the document containing the same information on the number of hits recorded by the SIRENE Bureaux in each period were accessible from the outset (for example documents 7389/13 and 8281/12).

We would kindly like to draw your attention to the fact that documents relating to the number of hits recorded by the SIRENE Bureaux in each period have always been issued as non-public documents (for example documents 14242/13 and 9075/12) due to their sensitive contents, as explained in the reply to your initial request. However, documents setting out Schengen information system database statistics for a given period have always been issued as public documents. This was the case for example with documents 7389/13 and 8281/12 which you mention. The Schengen information system database statistics for the period of 1 January 2013-31 December 2013 have not yet been prepared; the document containing this data is expected to be issued in March 2014. This is why we unfortunately cannot send it to you yet.

On the basis of the above, could you please confirm us whether you wish to maintain your confirmatory application? If this is the case, your confirmatory application will be handled under Article 7 of Regulation (EC) No 1049/2001. It will be examined by the Working party on Information, the Council's preparatory body dealing with transparency matters, and the reply to it will then be submitted to the Permanent Representatives Committee and the Council for approval.
