1. The General Secretariat of the Council has been informed of the resignation of Mr Zdeněk ŠMERHOVSKÝ, as alternate member of the Governing Board of the above Agency in the government representatives category (for Czech Republic).
2. Under Article 8 of Regulation (EC) No 2062/94, as amended by Regulation (EC) No 1112/2005, members of the Governing Board are appointed by the Council.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EC) No 2062/94 of 18 July 1994 establishing a European Agency for Safety and Health at Work<sup>1</sup>, and in particular Article 8 thereof,

Whereas:

- (1) In its Decisions of 17 October 2016<sup>2</sup>, of 28 November 2016<sup>3</sup> and of 23 January 2017<sup>4</sup> the Council appointed the members and alternate members of the Governing Board of the European Agency for Safety and Health at Work for the period ending on 7 November 2019.
- (2) A seat as alternate member in the government representatives category has fallen vacant as a result of the resignation of Mr Zdeněk ŠMERHOVSKÝ.
- (3) The government of Czech Republic has nominated a candidate for the vacant seat,
