# NOTIFICATION OF THE REPLACEMENT OF A FINNISH ALTERNATE MEMBER OF THE COMMITTEE OF THE REGIONS

Katri Kulmuni, alternate member of the Committee of the Regions, has resigned from the Committee. In Finland candidates for the Committee of the Regions are nominated by the government plenary session. On 2 March 2017 the government decided to propose as a new alternate member of the Committee of the Regions Merja Lahtinen of Jämsä City Council, who fulfils the eligibility criteria.
