Declaration of Denmark
in accordance with Article 36(2) of Council Decision 2008/615/JHA of 23 June
2008

In accordance with Article 36(2) of Council Decision 2008/615/JHA of 23 June 2008 Denmark declares that it has fully complied with the provisions of that Decision as well as the relevant provisions of Council Decision 2008/616/JHA of 23 June 2008 and Denmark is willing to apply these Decisions in its relations with those Member States which have given the same notification.

Denmark has implemented the abovementioned Decisions with regard to exchange of DNA profiles, Vehicle Registration Data and dactyloscopic data in 2008 (Act No. 479 of 17 June 2008) and with regard to Data Protection in 2014 (Administrative Order No. 882 of 4 July 2014). The legislation with regard to DNA profiles and Vehicle Registration Data, as well as Data Protection, entered into force 1 August 2014. The legislation with regard to dactyloscopic data entered into force 1 July 2016.

For the purpose of Article 19 of Decision 2008/616/JHA, the independent data protection authority is the Danish Data Protection Agency.
