RECOMMENDATION FOR A COUNCIL DECISION AUTHORISING THE OPENING OF
NEGOTIATIONS ON AGREEMENTS BETWEEN THE EUROPEAN UNION AND THIRD
COUNTRIES LAYING DOWN THE TERMS AND CONDITIONS FOR THEIR
PARTICIPATION IN THE PARTNERSHIP FOR RESEARCH AND INNOVATION IN
THE MEDITERRANEAN AREA (PRIMA), JOINTLY UNDERTAKEN BY SEVERAL
MEMBER STATES

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular <u>Articles</u> 185 and the second subparagraph of Article 188 in conjunction with Article 218(3) and (4) thereof,

Having regard to the recommendation from the Commission,

Whereas:

- (1) Regulation (EU) No 1291/2013 of the European Parliament and of the Council established Horizon 2020 The Framework Programme for Research and Innovation (2014-2020) ("Horizon 2020"). Horizon 2020 aims at achieving a greater impact on research and innovation by contributing to the strengthening of public-public partnerships, including through Union participation in programmes undertaken by several Member States in accordance with Article 185 of the Treaty on the Functioning of the European Union (TFEU).
- (2) On 18 October 2016, the Commission adopted a proposal for a Decision of the European Parliament and of the Council on the participation of the Union in Partnership for Research and Innovation in the Mediterranean Area PRIMA on the basis of Article 185 TFEU ("basic act").

Regulation (EU) No 1291/2013 of the European Parliament and of the Council of 11 December 2013 establishing Horizon 2020 – the Framework Programme for Research and Innovation (2014-2020) and repealing Decision No 1982/2006/EC (OJ L 347, 20.12.2013, p. 104).

- (3) PRIMA aims at implementing a joint programme for the development and the adoption of innovative and integrated solutions for improving the efficiency, safety, security and sustainability of food production and water provision in the Mediterranean area.
- (4) <u>Nineteen</u> countries have agreed to jointly undertake PRIMA by committing financial contributions: the Member States <u>Croatia</u>, Cyprus, Czech Republic, France, <u>Germany</u>, Greece, Italy, Luxembourg, Malta, Portugal, <u>Slovenia</u> and Spain; the third countries associated to Horizon 2020 Israel, <u>and Turkey</u>; the third countries not associated to Horizon 2020 <u>Algeria</u>, Egypt, Jordan, Lebanon and Morocco.
- (5) Under the basic act, all Participating States should have the same rights and obligations. The third countries not associated to Horizon 2020 can however participate in PRIMA only subject to the conclusion of international agreements with the Union setting out the terms and conditions of their participation in PRIMA.
- (6) Negotiations should be open with a view to concluding international agreements with Algeria, Egypt, Jordan, Lebanon and Morocco, laying down the terms and conditions for their participation in PRIMA.
- (7) Negotiations to allow the participation of those third countries not associated to Horizon 2020 in PRIMA can be started on condition that the basic act is adopted.

HAS ADOPTED THIS DECISION:

Article 1

The Commission is hereby authorised to negotiate, on behalf of the Union, international agreements between the European Union and the third countries **People's Democratic Republic of Algeria**, Arab Republic of Egypt, Hashemite Kingdom of Jordan, Republic of Lebanon and Kingdom of Morocco, laying down the terms and conditions for their participation in the Partnership for Research and Innovation in the Mediterranean Area (PRIMA), subject to the adoption of the basic act.
