Subject:	Draft Council Regulation amending Annex III to Directive 2008/98/EC of the European Parliament and of the Council as regards the hazardous property HP 14 'Ecotoxic'
	- Adoption

1. On <u>25 October 2016</u> the Committee for the adaptation to scientific and technical progress and implementation of Directive <u>2008/98/EC</u> on waste did not give a favourable opinion on the draft Commission Regulation amending Annex III to Directive <u>2008/98/EC</u> of the European Parliament and of the Council as regards the hazardous property HP 14 ('Ecotoxic'). Consequently, on <u>19 January 2017</u>, the <u>Commission</u> transmitted to the Council, and forwarded to the European Parliament (EP), a proposal for a Council Regulation on the above-mentioned subject.¹

- 2. On <u>20 March 2017</u>, the <u>Council</u> agreed, by written procedure², to submit the draft Council Regulation as annexed to document <u>7129/17</u> to the European Parliament in accordance with article 5a(4)(d) of Council Decision <u>1999/468/EC</u> ('the Comitology Decision')³.
- 3. The <u>European Parliament</u> did not oppose the adoption of the above proposed measures within the stipulated deadline of 19 May 2017, as provided for by Article 5a(4)(e).
- 4. The text of the draft Council Regulation referred to above has now undergone legal and linguistic finalisation and is set out in doc. 8430/17.
- 5. In view of the above, the <u>Committee of the Permanent Representatives</u> is invited to recommend the <u>Council</u>:
 - to adopt, by qualified majority, the draft Council Regulation as set out in the Annex to document 8430/17, in accordance with Article 5a(4)(g) of the Comitology Decision, with <u>LU, PL, NL, AT, BE, CZ, FR and FI</u> voting against and <u>BG</u> abstaining;
 - to include in the minutes of the Council meeting the joint statement from \underline{AT} and \underline{CZ} and the statement from \underline{BE} in the addendum to this note; and
 - to publish the Council Regulation in the Official Journal of the European Union.
