COUNCIL DECISION

authorising the opening of negotiations on a Convention on the recognition and enforcement of judgments in civil and commercial matters (the Judgments Convention) in the framework of the Hague Conference on Private International Law

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 81(2)(a), 218(3) and (4) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) In 2012, the Council of General Affairs and Policy of the Hague Conference on Private International Law approved the start of preparatory work on a draft convention on the recognition and enforcement of judgments in civil and commercial matters ('Judgments Convention');
- (2) In October 2015 a Working Group of the Hague Conference finished its work on an informal text proposal for the core of such a Judgments Convention;

- (3) At its meeting in March 2016, the Council of General Affairs and Policy of the Hague Conference approved the launch of negotiations on the proposed Judgments Convention;
- (4) Negotiations on the proposed Judgments Convention will formally start in a Special Commission of the Hague Conference on 1 June 2016;
- (5) Regulation EU (No) 1215/2012 of Parliament and of the Council (Brussels I recast)¹ provides for comprehensive rules on jurisdiction of the courts and recognition and enforcement of judgments in civil and commercial matters applicable within the Union. The Union has concluded the 2007 Lugano Convention² which ensures recognition and enforcement of judgments in civil and commercial matters between Union Member States, EEA States and Switzerland;
- (6) The proposed Judgments Convention will set rules for the recognition and enforcement of judgments in civil and commercial matters in a broad multilateral context. The proposed convention would complement the existing Union framework, including Regulation EU (No) 1215/2012 (Brussels I recast), the 2007 Lugano Convention and the 2005 Choice of Court Convention³, and would ensure the circulation of judgments given in the EU beyond the existing circulation among EU Member States, EEA States and Switzerland. The Union should therefore participate actively in the negotiations on that Convention;

The 2005 Choice of Court Convention entered into force on 1 October 2015 and is part of the Union *acquis* (Council Decision 2014/887/EU of 4 December 2014 on the approval, on behalf of the European Union, of the Hague Convention of 30 June 2005 on Choice of Court Agreements (OJ L 353, 10.12.2014)).

- (7) The Union has exclusive external competence with regard to the matters dealt with by the proposed Judgments Convention. The envisaged convention will affect common rules of the existing Union framework, in particular Regulation EU (No) 1215/2012 (Brussels I recast).
- (8) The United Kingdom and Ireland are bound by Regulation EU (No) 1215/2012 (Brussels I recast) and are therefore taking part in the adoption and application of this Decision;
- (9) In accordance with Articles 1 and 2 of Protocol No 22 on the position of Denmark, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union, Denmark is not taking part in the adoption of this Decision and is not bound by it or subject to its application;

HAS ADOPTED THIS DECISION:

Article 1

The Commission is hereby authorised to negotiate, on behalf of the Union, a Convention on the recognition and enforcement of judgments in civil and commercial matters (the Judgments Convention) in the framework of the Hague Conference on Private International Law.

Article 2

The negotiating directives are set out in the Annex.

Article 3

The negotiations shall be conducted in consultation with the Council Working Party on Civil Law Matters which is the special committee hereby designated pursuant to Article 218(4) of the Treaty on the Functioning of the European Union.

Article 4

This Decision is addressed to the Commission.

Article 5

This Decision shall take effect on the day following that of its adoption.
