Subject:	- Proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund in accordance with Point 13 of the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management (application EGF/2013/008 ES/Comunidad Valenciana textiles form Spain) - Proposal for transfer of appropriations No DEC 01/2014 within Section III - Commission - of the general budget for 2014

1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 5883/14 FIN 80 SOC 60, accompanied by the corresponding proposal for transfer of appropriations No DEC 1/2013, as recorded in document 5907/1/14 REV 1 FIN 14.

2. The proposal aims at mobilising an amount of EUR 840 000 under the EGF to meet an application from Spain to deploy the Fund in connection with 300 redundancies in 198 enterprises operating in the textiles industry. The redundancies were caused by major structural changes in world trade patterns due to globalisation which have led to a substantial increase of imports into the EU and to a loss of the EU market share in world markets.

The purpose of the proposed transfer is to move an amount of EUR 840 000 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

3. The Budget Committee examined both proposals at its meeting on 11 February 2014.
4. Following that examination, the Budget Committee agreed, by a qualified majority, to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the draft Decision on the mobilisation of the EGF as set out in ANNEX 1;
 - approve the proposed transfer of appropriations;
 - approve the draft letter in ANNEX 2 to that effect.

Draft Decision of the European Parliament and of the Council

on the mobilisation of the European Globalisation Adjustment Fund, in accordance with Point 13 of the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management (application EGF/2013/008 ES/Comunidad Valenciana textiles from Spain)

THE EUROPEAN PARLIAMENT AND THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 1927/2006 of the European Parliament and of the Council of 20 December 2006 establishing the European Globalisation Adjustment Fund, and in particular Article 12(3) thereof,

Having regard to Regulation (EU) No 1309/2013 of the European Parliament and the Council of 17 December 2013 on the European Globalisation Fund (2014-2020) and repealing Regulation (EC) No 1927/2006¹, and in particular Article 23, second subparagraph, thereof,

Having regard to Council Regulation (EU, Euratom) No 1311/2013 of 2 December 2013, laying down the multiannual financial framework for the years 2014-2020², and in particular Article 12 thereof,

Having regard to the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline, on cooperation in budgetary matters and on sound financial management³, and in particular Point 13 thereof,

Having regard to the proposal from the European Commission⁴,

Whereas:

- (1) The European Globalisation Adjustment Fund (EGF) was established to provide additional support for workers made redundant as a result of major structural changes in world trade patterns due to globalisation and to assist them with their reintegration into the labour market.
- (2) Regulation (EU, Euratom) No 1311/2013 allows the mobilisation of the EGF within the annual ceiling of EUR 150 million.

- (3) Spain submitted an application to mobilise the EGF, in respect of redundancies in 198 enterprises operating in the NACE Revision 2 Division 13 (Manufacture of textiles) in the NUTS II region of Comunidad Valenciana (ES52), on 8 October 2013 and supplemented it by additional information up to 5 November 2013. This application complies with the requirements for determining the financial contributions as laid down in Article 10 of Regulation (EC) No 1927/2006¹. The Commission, therefore, proposes to mobilise an amount of EUR 840 000.
- (4) The EGF should, therefore, be mobilised in order to provide a financial contribution for the application submitted by Spain.
- (5) Notwithstanding Regulation (EC) No 1927/2006 being repealed, it shall continue to apply for applications submitted up to 31 December 2013 by virtue of Article 23, second subparagraph of Regulation (EU) No 1309/2013,

HAVE ADOPTED THIS DECISION:

Article 1

For the general budget of the European Union for the financial year 2014, the European Globalisation Adjustment Fund (EGF) shall be mobilised to provide the sum of EUR 840 000 in commitment and payment appropriations.

Article 2

This Decision shall be published in the *Official Journal of the European Union*.
