- 1. The <u>General Secretariat of the Council</u> has been informed by the Danish Government of its decision to nominate Ms Lise Lotte TOFT as its member in the category of Government representatives on the CEDEFOP Governing Board, replacing Mr Lars MORTENSEN.
- 2. Under Article 4 of Regulation (EEC) No 337/75, as amended by Regulation (EC) No 2051/2004, the members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof ¹,

Having regard to the nomination submitted by the Danish Government,

Whereas:

- (1) By its Decisions of 14 July 2015² and of 14 September 2015³, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2015 to 17 September 2018.
- (2) A member's seat is available for Denmark on the Governing Board of the Centre in the category of Government representatives as a result of the resignation of Mr Lars MORTENSEN.
- (3) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2018.
